## The KidSport™ Program

The KidSport™ program helps children and families overcome financial barriers which prevent or limit their participation in organized sport. It is administered by

### Eligibility

Families with children **aged 18 and under** are eligible for support. There is no limit as to the number of children (aged 18 and under) in a family who may receive a grant.

Eligibility is based on **family income level**.

Sport activities must be those that demonstrate a **sustained** sport experience (i.e. a season of sport led by qualified coach/instructor).

Sport activities must be affiliated with member sport organizations of Sport PEI.

### Grant Criteria

A child may receive only one grant per calendar year. However, the grant may be applied to more than one sport.

The grant may be applied to a sport's registration or membership fees or mandatory personal sport equipment.

The range of grant available is from **\$20 - \$300** per child. The grant will be applied to actual registration and/or mandatory equipment costs only.

No portion of the grant is transferable to another family member.

Approval is given by the KidSport™ Allocation Committee only. No other organization has the authority to approve any application nor are they involved in the decision making.

Previous acceptance does not suggest continued support. Applications must be received and approved each year.

### Approval

Applications will be reviewed by the KidSport™ Allocation Committee. Approval is conditional based on the following criteria.

- Families who are identified as having a specified level of **net** annual family income (outlined in the chart below). Submission of the family's **GST Tax Credit or Canada Child Tax Benefit** is required, which outlines the following: net income, marital status and RRSP contribution for the most recent tax year.

- Families who are in receipt of financial assistance as indicated, in writing, by a representative of Child and Family Services, Government of Prince Edward Island.
